- 1. **No Entry Fee**. All sheep will be examined by a state veterinarian and sheep committee as to health charts, ear tags and registration papers. All exhibitors shall be present at this time. All animals must be in place by 5 PM on Monday. All entries must remain in place until Saturday at 8 PM.
- 2. Market lambs for competition shall have been shorn within 30 days of exhibition.
- 3. All entries must carry the registration tag of their breed (if available) in their ear, and registration numbers and certificates will be required on all entries at time of veterinarian check.
- 4. All entries must be brought out of their pens to be shown, failure to do this will cause forfeiture of prizes.
- 5. Exhibitors must clean their own pens and have them inspected and approved by the Superintendent before receiving premiums. Premium checks will be distributed in the barn on Saturday night and Sunday morning AFTER pens are cleaned. Failure to clean pens will cause forfeiture of premiums. Exhibitors will furnish own forks for this purpose.
- 6. Each exhibitor shall present a health certificate signed by an accredited veterinarian indicating that his flock is free of all contagious and infectious diseases, and is not under quarantine. All sheep will be inspected by Delaware County Sheep Committee, and veterinarian. Any sheep exhibiting evidence of contagious diseases, internal or external parasites or in a generally unthrifty condition will be sent home immediately.
- 7. Anyone leaving without a release from the superintendent will receive no remiums.
- 8. Exhibitors on return home shall keep all animals segregated from the flock for at least two weeks. The Delaware County Fair accepts no responsibility in case of loss or damage to stock, and upon this condition only are entries received.

- 9. The decision of the judge shall be final in all cases except where error, fraud, misrepresentation or collusion, not discovered at the time of the award, is proven. In such cases the superintendent, or such referees as he may appoint, may make a decision. This decision will be final.
- 10. Each exhibitor is limited to no more than two (2) entries per class. In all group exhibits one premium perexhibitor.
- 11. No sleeping in the sheep Barn. Any special requests on this matter must be submitted to all the superintendents in writing. Please include your reasons for this request. You will be notified of their decision.
- 12. All exhibitors of purebred stock are required to present registration papers, health papers and transfer papers, bearing name of owner, to the superintendent when called for.
- 13. No Sheep will be allowed to enter the barns until Vets have cleared them. Animals will be checked in on Saturday from 11 a.m. to 8 p.m., Sunday from 8 am to 6 p.m. and Monday from 8 a.m. to 5 p.m.

Exhibitors must truck their animals to the staging area where Vets will review them. Following clearance by veterinarians. Animals will be allowed to enterbarns.

All shippers of livestock should possess Health papers for the sheep they are transporting. A State Vet will check each animal. If there is a question, the decision of the State Vet and the superintendent will be final.. The Vet will be checking animals periodically throughout the week.

Out of state animals must have interstate health and shipping papers.

## Section 019 -- Fleece Classes

Fleeces should be rolled with skin side out and place in a plastic bag or basket. Fleeces may be opened by the judge. Each fleece must be tagged with breed name, class number and exhibitor's number. Fleeces will be tagged with numbers given exhibitors as brought into the sheep barn and must be in place by 5 PM on Monday.

Fleeces will be judged Tuesday and exhibitor's name and address will be placed on fleece tags following judging. Fleeces must remain in place until 8 PM on Saturday. Standards for judging include: length and quality of fiber, strength of staple, broken fibers or second cuts and excess of foreign matter.

Entry fee is \$1 per fleece. Prizes are as follows: 1st - \$8.80 2nd - \$6.60 3rd - \$4.40
