## **EXHIBITORS FORM**

The following rules MUST be followed by all campers who use this service. Your cooperation will be greatly appreciated.

- 1. New York State rule: NO AWNINGS OR TENTS BETWEEN CAMPERS
- 2. NO open fires or charcoal grills or GAS GRILLS.
- 3. No Parking of Campers before Friday 8 AM
- 4. You must check in with person in charge before parking camper.
- 5. No one under the age of 21 will be allowed to stay in a camper without Adult supervision.
- 6. Water and Electric hook-ups are limited.
- 7. ALL CAMPERS MUST HAVE ANTI-SIPHON VALUE BETWEEN THE END OF THEIR WATER HOSE AND THE WATER CONNECTION. If you do not have one, they can be purchased at the Fair.
- 8. ALL HOLDING TANKS MUST BE CLOSED.
- 9. NO DUMPING OF GRAY WATER DURING THE TIME THE CAMPER IS AT THE FAIR.
- 10. A pumping service will be available once during the Fair. Sign up at check in.
- 11. PARKING SPACE LIMITED TO 1 CAR PER CAMPER.
- 12. In consideration for all campers, **QUIET HOURS** will be from 10:00 p.m. until 7:00 a.m. No loud music, talking, etc. will be tolerated during these times. **NO ALCOHOLALLOWED.**
- 13. Air conditioners may be operated in specified spaces only. The fee for those spaces is \$225
